## Summary of April 1, 2020 Meeting

What follows is a summary of the meeting of the Alabama Ethics Commission held on April 1, 2020, not the official minutes of that meeting. This summary is being prepared and disseminated via our website immediately after the meeting due to the fact that the Commission is operating with a reduced staff as a result of the coronavirus pandemic as well as Governor Kay Ivey's recommendations for staffing state agencies during this period of time. Accordingly, we were unable to simulcast our meeting as is customary.

Ms. Brady, Vice Chair, called the meeting to order at 9:34 a.m.

Chief Justice Stuart moved to adopt the February 5, 2020 meeting minutes as written. Judge Price seconded the motion. The minutes were unanimously approved in a roll call vote.

There were no Advisory Opinions considered by the Commission. There were no FCPA appeals considered by the Commission.
